Phil Alt presented reported that the average census numbers are trending higher.

Phil Alt provided a financial analysis. He explained that the cash flow will improve when the millage comes in after the beginning of the year.

Don Haney asked the board to increase the private pay rate to \$510.00 effective February 1, 2025. Rayann Franco provided a report for Corporate Compliance. Data for the payroll based journal was not submitted correctly. The staff were provided with education on the correct way to submit the data. Don Haney explained that there will be changes made in the business office but that nobody will lose their job.

The Board thanked Don Haney for his services.

Dr. James Wierman stated that he spoke with Joseph Gavan, C.E.O. of the Cass Family Clinic about providing physicians for the facility. A meeting will be set up after the first of the year.
